IN JULY 2015, LANGE FOUNDATION STARTED A SAFETY NET PROGRAM AT THE LANCASTER ANIMAL SHELTER WHEREBY LANGE FOUNDATION STAFF MEMBERS WERE ON THE PREMISES AT ALL TIMES WHEN THE SHELTER WAS OPEN TO TRY TO DISSUADE PET OWNERS FROM RELINQUISHING THEIR PETS TO THE SHELTER BY PROVIDING MEDICAL CARE, SURGERIES, TRAINING, TEMPORARY BOARDING, FOOD AND SUPPLIES AND ALSO HELPING OWNERS RETRIEVE THEIR LOST PETS BY PROVIDING FUNDS WHEN THE OWNER WAS UNABLE TO PAY THE REDEMPTION FEES. 783 PETS WERE HELPED DURING THE FIRST YEAR OF THIS PROGRAM.
